Terms and conditions.

- 1. Bidders have to deposit Rs 25000/- (Rupees twenty five thousand only) for this tender as an Earnest Money Deposit (EMD) in the form of Demand Draft of any authorized bank in Favour of **ICAR Unit-CTCRI** payable at **Thiruvananthapuram** and will be refundable to unsuccessful bidders. The quotation will not be considered if Earnest money is not deposited. No interest on Earnest money deposit shall be paid by the Institute to the bidders.
- 2. No employee of ICAR-CTCRI shall participate in this tender.
- 3. The successful bidder should remit 25% of the amount quoted by the party on the same day of acceptance of the rates. The balance amount should be remitted within Three (03) days from the date of acceptance.
- 4. Successful bidder has to lift the animals within three day of completion of the award and this office will not remain responsible for any further complications after the stipulated period.

- 5. The Animals will be sold on and above the reserve price fixed by the committee/book value or market value which is higher thereof through open bidding. If the quoted H-1 price is below the price fixed by the committee, the animals will not be sold to the H-1 bidder.
