
- Earnest money of **Rs 2000/-**[refundable] must be deposited as cash or in the form of DD in favour of **Director 'ICAR Unit-CTCRI'** Payable at Thiruvananthapuram. The quotation will not be considered if Earnest Money is not deposited. No interest on Earnest Money deposit shall be paid by the Institute to the bidders. EMD will be stand forfeited in the event of any tender condition violations.
- The bids received after the specified date and time will not be considered.
- Interested parties may visit the Farm Office of the Institute on any working day between 10.00 AM and 3.30 PM upto 16.02.2026 to assess the fruit bearing trees before quoting their rates

### **Terms and conditions.**

1. The successful bidder should remit 25% of the amount quoted on the same day.
2. The balance amount should be remitted within seven [07] days from the date of acceptance. Prior approval of the competent authority should be obtained for harvesting. The labourers will be allowed to harvest after obtaining the written permission of the Scientist-in-Charge(Farm)/Officer-in-Charge Farm at each occasion. **Complete harvesting should be done on or before 31.07.2026.**



3. Tenderers should clearly quote their rates as per bid Performa (Annexure II). The rates should be written in figures and in words. Any overwriting on rates or any change and/or alteration without attestation is liable to rejection of the tender. In case there is any error/mismatch between the amount specified in figures and words, the amount written in words will be taken as final. The amount quoted in Annexure-II of the bid shall be paid by the successful bidder to the Organization without any deduction for taxes, duties, cartage, Labour charges/loading/unloading charges etc. Bid for partial lot will not be accepted.
4. Harvesting should be done only on working days of Institute. If the harvest is not completed within the allotted period, the office will not be responsible for any loss.
5. While harvesting no damage should be made to other crops/trees/properties of the Institute.
6. If there is any misbehavior from any of the labourers engaged for harvesting, they will be sent out from the spot immediately.
7. The Director ICAR-CTCRI reserves the right to accept or reject the bid and also to stop the harvest at any time during its validity period in the interest of the Institute, for any justifiable reasons, not mandatory to be communicated to the tenderer.


